ORDINANCE No. 275–10-9-2018

AN ORDINANCE OF THE CITY OF WEST TAWAKONI, TEXAS AMENDING ORDINANCE NO. 256-11-10-2015 REQUIRING POLY CART/S MANDATORY FOR ALL RESIDENTIAL HOUSEHOLDS; RATES FOR THE COLLECTION OF RESIDENTIAL & COMMERCIAL HANDHELD CUSTOMERS; RATES FOR THE COLLECTION OF COMMERCIAL CONTAINERS (DUMPSTERS) RANGING FROM (2) YARD TO (8) YARD; PROVIDING FOR THE COLLECTION OF A DEPOSIT FOR COMMERCIAL CONTAINERS (DUMPSTERS); PROVIDING FOR USE OF CITY DUMPSTER AT THE WASTE WATER TREATMENT PLANT WITH PROOF OF PAYMENT; RATES FOR USE OF CITY DUMPSTERS AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of West Tawakoni provides trash collection services to all residents and commercial businesses of the City; and

WHEREAS, Contractor, Sanitation Solutions agrees to provide (1) 96-gallon Poly Cart(s) services to each household;

WHEREAS, the City of West Tawakoni requires a Deposit for Commercial Container/Dumpsters;

WHEREAS, the City of West Tawakoni shall require all poly carts be placed by the curb no earlier than 7:00 a.m. on the day before pickup and must be removed on the day after pickup no later than 7:00 p.m.;

NOW, THEREFORE, BE IT ORDAINED THAT ORDINANCE NO. 256-11-10-2015 BE AMENDED AS FOLLOWS:

- 1. The current base rate for residential service: Garbage w/ (1) cart \$17.00; Garbage w/ (2) carts \$24.00; Garbage w / (3) carts \$30.00; (plus sales tax for residential service inside city limits 8.25% / sales tax for residential service outside city limits 6.75%; effective December 1, 2018 billing cycle.
- 2. Commercial rates: See attached schedule for rates effective November 13, 2018, following publication in the official newspaper beginning with the December 1, 2018 billing cycle.
- 3. Use of City Dumpsters at the Waste Water Treatment Plant will be made available by appointment only for use by City Residents for a non-prorated charge with a current water bill stub and proof of payment of required fee below at city hall. No batteries, building materials, paint, tires or appliances may be disposed of in the City Dumpster:

Pickup or car - \$30.00; Trailers up to 16' in length - \$60.00 Trailers over 16' in length - \$150.00

SEVERABILITY: If any section, provision, or part of this Ordinance be determined to be invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof, not adjudicated invalid or unconstitutional.

EFFECTIVE DATE: The Ordinance will take affect following a regular meeting, first reading on October 9, 2018, and second reading on November 13, 2018 in which the City Council voted as follows:
