1. Call to Order

2. Invocation

5. Announcements

James Chemp moved to forgive \$2000 on the principal of the loan at the end of the first year if the payments are made, and the restaurant maintains 15 full-time employees. The matter will be revisited each year. Kathey O'Neal seconded the motion, and it carried unanimously.
