# Regular Meeting Agenda Minutes

## August 7, 2023

#### 1. Call to Order

President Pam Reed called the meeting to order at 7:02 p.m.

## 2. Invocation

Elizabeth Osborne led the invocation.

## Pledge

The Pledge of Allegiance was led by all in attendance.

## 4. Roll Call

James Chemp, Pam Reed, Elizabeth Osborne, Kathey ONeal and Larry Pare were in attendance. Harry Rosario and Aliceson Zurovec were not present. Two citizens were present.

**Agenda Item 9**. At the suggestion of president Pam Reed, New Business (agenda item 9) was moved to a higher place on the agenda to accommodate citizens in attendance.

- a. Discuss and select business of the month. A motion by Kathey O'Neal, seconded by Elizabeth Osborne to select Dales Burgers as Business of the Month passed unanimously. The business will be highlighted on the website. New owners will be interviewed and appreciation will be expressed for their generous donations.
- b. Discuss Market on the Lake. Following a discussion of limited visibility of Market on the Lake, Elizabeth Osborne moved to allow Market vendors to utilize the front of EDC property for the monthly event. The motion was seconded by Larry Pare and passed unanimously.
- c. Discuss Cotton Patch Challenge sponsorship. The Cotton Patch Challenge, sponsored by the Greenville Rotary Club, is a 100-mile bicycle ride beginning in Greenville extending through Lone Oak and Pont, turning at Emory and going through East Tawakoni, West Tawakoni and Quinlan. Two Tawakoni Chamber of Commerce members discussed the September 16, 2023, event and the various sponsorships available for purchase. The Chamber will provide a rest stop for riders at the Chamber building. Food and drink vendors will be invited to set up to hopefully provide the best rest stop of the ride. A motion by Elizabeth Osborne, seconded by Kathey O'Neal to purchase the Finish Line sponsorship at a cost of \$2250 passed unanimously. Sponsors will be advertised by various means before and throughout the ride. Suggested wording of "Bring Your Business to the Lake" was suggested. President Reed pointed out that the sponsorship will use the last of the advertising budget for September.
